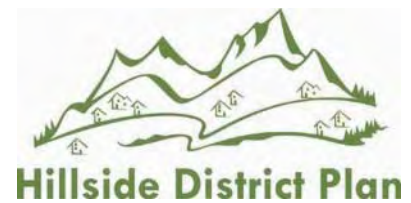


## Hillside District Plan CAC Members
